DEVELOPING POINTS & CHANGES OF LOGISTICS

1. Cross-Border Trans-shipment Delivery

- Consumer behaviors change due to increase of average income. E-commerce replacing the actual stores.
- Increment of Taiwan's air freight volume and revenue.
- Euro-bound export. (higher income).
- Cross-Border parcel delivery.

2. Overseas Fulfillment Center

- California 、 Texas 。
- Became distribution center for overseas parcel delivery.
- Solving problems on inventory and laboring for small e-commerce businesses.

3. Last Mile

- Charge by piece. (More than 10 thousands pieces per day.
- Different from air freight (charge by Kgs).
- Developing new delivery service mode and offering more choices for customers.



- Use traditional air and ocean freight experience , guaranteed spaces as the stepping stone for cross-border e-commerce practice.
- Transportation methods changed due to behaviors change.
- Diversified transportation to offer different solutions to different customers.

Feb.

- TPE – China (Shanghai 、 Hongchiao 、 Chengdu 、 Xiamen 、 Beijing) 、 Hong Kong and Macau export air freight charges increased twice.
- China and Macau export air freight charges increased ; air freight charges from USA to Asia reached all time high.

Mar.

- TPE to Korea , Southeast Asia to and from Taipei air freight charges increases two to three times.
- TPE – USA air freight charges increases 15~20% 、 TPE- Europe air freight increases 15 %.
- Italy Philippines borders closed.

Apr.

- China and Macau export freight charges for the second and third time.
- Flight space offers to medical suppliers or charter services
- Fuel charge adjustment.
